## **We collect data from you. Which? Where from? How long? And are we permitted to do this at all?**

## **Are we obliged to collect these data? What happens if we do not collect these data?**

There is no obligation to collect all data. The obligation to store those data, which we actually collect and otherwise process, is derived from tax and commercial law regulations.

## **To whom do we transmit the data? And: Do the data leave the European Union or the European Economic Area?**

Ciech S.A. Branch of Germany has been commissioned by us to store personal data for us. It was selected carefully and commissioned for this purpose and is monitored permanently. It has, on its part, commissioned the Polish Ciech S.A. herewith. Otherwise, the data are not transmitted to other third parties, in particular not to such bodies outside of the European Union or the European Economic Area.

## **Which rights do you have?**

You have several rights. You have the right to information about the personal data processed in relation to your person as well as to rectification or erasure, to limitation to the processing, to object to the processing as well as to data portability. Furthermore, you have the possibility to lodge a complaint about us at the supervisory authority that is responsible for us. We politely point out that this right is, if applicable, linked to prerequisites, the existence of which we will insist upon.
